#### ONLINE DOG LICENSING **PROGRAM AVAILABLE** THROUGH YAVAPAI COUNTY

Last year, the Yavapai County

Sheriff's Office launched a website providing dog owners the ability to obtain licenses, maintain pet records, and even report an animal missing. The Sheriff's Office urges Yavapai County Dog Licensing



dog owners to take ad-

vantage of the free program and apply. Once an account is created the following tools are available:

1. Dog License: A 1-3 year license can be purchased. Licensing requirements may be viewed on the homepage.

2. Renewal: A license can be renewed. A license renewal can be paid up to three years of the rabies vaccination period via Pay Pal or a credit card through Pay Pal.

3. Dog Tag: The current Yavapai County dog tag is a permanent tag, which requires a yearly registration fee. An email notification will be sent after the due date.

4. Email Notifications: Receive email notifications on rabies vaccinations and licenses.

5. Co-guardianship: Dog owners can appoint secondary people for co-guardianship, which allows lost and found along with licensing and rabies notification.

6. Countywide Lost and Found: With a click of a button, a dog can be labeled lost or found. The website can be searched for lost dogs in the area.

To register an account, click on the 'Create a login' link in the left hand menu of the home page at http:// ycsoaz.sheltertrack.com and fill in the requested information. Non-account holders can access limited portions of the website such as the Lost and Found page and Calendar of Events.

For those without computer access, dog licenses may be purchased from humane societies, sheriff's offices, low-cost spay and neuter clinics, and through the mail. #### **D-H CODE ENFORCEMENT** ANNOUNCEMENT

#### TEMPORARY HOUSING PERMITS IN D-H

Town Code of Dewey-Humboldt provides that the Building Official is authorized to issue a permit for temporary

housing to be occupied during the life of an active building permit.

Town Code Section 153.036.B(8)

Occupancy of temporary housing, including travel trailers, recreational vehicles and single-wide manufactured homes during the construction of a permanent dwelling is allowed during the 24-month period after the issuance of a building permit, as long as the building permit remains valid.

A permit for the temporary housing must be obtained prior to occupancy of the temporary dwelling unit. One extension of time for use of temporary housing may be granted at the discretion of the Zoning Administrator or his/ her designee for a period not to exceed the maximum life of the original building permit (24 months, plus one sixmonth extension).

### SAFETY TIPS FROM THE **BUILDING OFFICIAL**

Gas Fuel Appliances: Change out air filters, check appliances for gas leaks and check out exhaust and combustible air ventilation systems. It is recommended to have a licensed mechanical contractor do a complete check-up on the gas heating system. A carbon monoxide detector is also a highly recommended device if you use gas-fuel appliances.

#### Smoke Alarms:

Replace the batteries and TEST the alarms to make sure they are in good working order.

#### Stoves and Fireplaces:

Clean the flue/exhaust pipes regularly to ensure your appliances work more efficiently.

#### **Doors and Windows:**

Replace any worn out weather stripping around the doors and windows.

### FREE WELL WATER TEST-ING IS AVAILABLE AGAIN!

Responding to an overwhelming demand following the first two rounds

of well water testing program, kit The Town of Dewey-Humboldt is offering to **Residents of the** Town, who have not previously participat-



ed, free testing of drinking water sampling from local Residents' well systems.

While they last, sample bottles can be reserved in advance, for pickup at Town Hall from 8:00 am till 12:00 pm from Wednesday, February 21, 2018 through Friday, February 23, 2018.

Residents are encouraged to return the filled bottles the day they are picked up, but they must be returned by 12:00 pm on Friday, February 23, 2018 in order to be transported to Nortest Analytical Laboratories, in Flagstaff, for testing.

Nortest Laboratories will email the results directly to participating Residents, when testing is completed.

Drinking water testing includes copper, lead, arsenic.

#### EPA TO PRESENT UPDATE **ON SUPERFUND SITE**

At the D-H Town Council meeting on February 20, 2018, the United States Environmental Protection Agency (EPA) plans to update the Town Council on EPA's work on the Iron King Mine/Humboldt Smelter (IKHS) Superfund site.

Superfund is a program that provides the authority and funding to clean up sites with contamination that poses a threat to human health or to the environment. The industrial operations at the former Iron King Mine

and the separate Humboldt Smelter took place over many decades from the late 1800s through the 1960s. They left behind arsenic and lead contamination. This contamination includes extensive mine tailings piles, tailings and contaminated sediments that move downstream in drainages during heavy rains, dams holding back mine wastes, soils contaminated by wind-blown tailings and smelter stack emissions, and fill materials made of mining wastes.

To understand the nature and extent of contamination in detail, in 2016 EPA finished a comprehensive remedial investigation - an extensive sampling study. Site-related contamination was found in nonresidential areas and also in a limited number of the almost 600 residential yards that were evaluated. Over the course of three cleanup actions in 2006, 2012, and 2017, EPA cleaned up soils in 50 residential yards. EPA's cleanup of yard soil contamination is now complete.

EPA is now working on a study of the options to clean up the contamination in the non-residential portions of the IKHS Superfund Site. This is called a *feasibility study*. In this feasibility study, a detailed comparison of several cleanup options will be made based on such factors as effectiveness, safety, perma-nence, feasibility, future land use, and cost. EPA will publish this evaluation in a future report and seek public input prior to selecting the final cleanup option.

While the feasibility study is not vet completed. EPA plans to update the town council on February 20 on progress and on the cleanup options.

## CLOSURES AT GRANITE MOUNTAIN AND THUMB BUTTE

Prescott National Forest officials will be implementing restrictions on climbing and other activities on the cliff faces of both Granite Mountain and Thumb Butte on Thursday, February 1, 2018. Both sites have been consistently occupied by peregrines annually for more than 20 years. These annual closures are providing the undisturbed setting and quality nesting habitat essential for peregrines to successfully raise their young.

The closures will begin February 1st and last until July 15th. For both locations, the closures will be the same as they have for over 20 years.

On Granite Mountain, it is prohibited to be upon any part of the Granite Mountain rock cliff face or the rim above the rock face and extending 100 feet back from the edge of the cliff face by rock climbing or any other means of access. Trail 261 will remain open.

On Thumb Butte, both the north and south climbing faces, the top of Thumb Butte, and the areas at the base of the climbing faces will be closed to entry. Trail 33 will remain open for hiking. These closures have provided the protection peregrines need to produce young birds from both nest sites.

Maps of the closed areas will be posted throughout both the Thumb Butte and Granite Basin Recreation Area. The Prescott National Forest is asking local birders to share their field observations of peregrine falcons with our resource managers to provide a better picture of peregrine nesting progress. Peregrine falcons were once listed

under the Endangered Species Act. They continue to be managed under the protection of the federal code of regulations as well as state law.



Land managers consider the

needs of the peregrines and the recreation desires of people to strike a balance where both can effectively use the same space at different times for their respective purposes.

## ORANGE CHICKEN W/ SWEET POTATOES

From The Busy Mom's Slow Cooker Cookbook

- 3 large sweet potatoes
- cut into 1/4" slices
- 2/3 cup flour
- 3/4 tsp. ground cinnamon

2 tsp. brown sugar

1/8 tsp. pepper

1/8 tsp. garlic powder

- 1 lb. boneless, skinless chicken breasts
- 1 10 3/4 oz. can low-fat cream of chicken soup
- 1/2 cup orange juice

Spray inside of slow cooker with cooking spray. Arrange potato slices in bottom of cooker. Combine flour, cinnamon, brown sugar, pepper, and garlic powder in a zip-lock bag and shake until mixed. Drop chicken in bag and shake to coat. Place chicken on top of potatoes. Combine chicken soup and orange juice in a medium bowl. Mix well and pour over chicken. Cover and cook on low for 8-10 hours or on high for 4-5 hours.
